### **Mental Health Local Operational Group Meeting, NHS Canterbury and Coastal CCG**

The Mental Health LOG meetings continue to be clinically led. The CCG ensures that feedback received at the MHAGs are fed into the LOG meetings (and visa-versa) to ensure that there is a true local flavour. The next NHS Canterbury and Coastal CCG LOG meeting will be on 12 January 2018.

### **PICU and MH Beds**

The East Kent situation remains as of the last 12 months with no out of area placements for acute patients and PICU out of area placements are kept to a bare minimum and of a short duration. KMPT hold fortnightly teleconference bed management calls on Friday's with EK MH Commissioners to monitor delayed transfers of care, acute and PICU (Psychiatric Intensive Care Unit beds) out of Kent placements.

### **Children and Young Persons Mental Health Service (CYPMHS)**

The service provider NELFT (North East London Foundation NHS Trust) ended their consultation with staff on 22 December 2017. The consultation was to develop new staff structures and care pathways. Interviews and restructure will commence January/February with the new service beginning on 1st April 2018.

### **NHS Veterans' Mental Health Complex Treatment Service (VHM CTS)**

The new Veterans' Mental Health Complex Treatment Service will be provided by Camden and Islington NHS Foundation Trust (appointed by NHS England).

### **Mother and Infant Mental Health Services (MIMHS)**

Kent and Medway NHS and Social Care Partnership Trusts' Specialist Mother and Infant Mental Health Service has received funding to develop its community perinatal mental health service across Kent and Medway with the new service launching on the 1 November 2017.

GPs are able to directly refer patients into this service.

A full report on Alternative Place of Safety workshops held in September and October was disseminated in November 2017. The summary report of these workshops and their findings was presented to the East Kent Care Crisis Concordat meeting in December 2017 and agreed as a way forward, an outline business case is now being developed.
